

Harvey Region RV Friendly Sites Terms & Conditions

The Shire of Harvey welcomes visitors with fully self-contained RVs and caravans to enjoy our free RV Short Stay Rest Areas in Brunswick Junction, Harvey and Yarloop.

These Terms & Conditions have been developed to encourage consideration and respectful behavior whilst staying within the Harvey Region RV Friendly short stay sites, and to ensure there is minimal impact on the public open space and nearby land owners.

They apply to **ALL** bookings.

Eligibility

- Visitors must meet the definition of fully self-contained to utilise these sites.
- To be considered fully self-contained vehicles must be fitted with on-board facilities such as toilets and sinks. These on-board facilities cannot be a separate item; they must be manufactured as part of the vehicle and plumbed in.
- If your vehicle does not meet these criteria, you will need to find an alternative location.

Bookings

RV friendly visitors are required to register and book via the Harvey Region Website booking system:

- Maximum of two (2) RVs three (3) RVs in Brunswick, Yarloop and Harvey at any one time.
- An online booking within an allocated bay is mandatory.
- If there is no site availability online, you must find an alternative location.
- Maximum period of stay is 48 hours only:
 - **Check in:** No earlier than 12pm (noon).
 - **Check out:** By 11am.
- Please note: to secure your allocated bay, you are required to administratively book from **12am to 12am** on the booking system. This does not require you to physically arrive at the administratively booked timeframes. See **How to Book Guidelines**.

- The time frame between one period of stay and the next period by the same RV is 28 consecutive days for each site.
- The Shire reserves the right to close the sites at any time. Please refer to the website for updates on closures.

Cancellations

- If you no longer require a booking, please ensure you cancel within 24 hours of your booking.

Your Stay

- All RV vehicles must fit within the designated bay lines that have been measured strategically to accommodate RV vehicles.
- There is ONE allocated RV bay per site booking for guest use. There is to be no extra vehicles parked in the designated RV bays or site.
- There must be no other annex/awnings or temporary structures erected within the bay nor outside the designated RV bay within the site:
 - Attachment of poles, ropes or other fixings to a tree or the ground are not permitted.
 - Clotheslines external to the RV are NOT permitted.
- No RV, caravan, or car washing is permitted.
- Please ensure your RV bay and site, as well as the facilities you use during your stay are kept clean and tidy.
- Please use the appropriate waste stations provided for waste disposal. Dump point information is available at <https://www.harveyregion.com.au/free-rv-parking/>
 - All grey and black-water must be discharged into vehicle holding tanks.
 - Discharge of wastewater (including greywater) is not permitted.
- On your departure, your rubbish must be taken with you.
- There is a NO smoking policy within the RV site
- No fire pits or any other fire related activity are permitted at ALL times.
- All micro-mobility devices such as bikes, scooters, rollerblades, skateboards and the like, can only be used during daylight hours and must adhere to relevant regulations refer to the *Local Government Property Local Law 2018*.

- A parent or guardian must supervise all children aged 14 years and under whilst on the Harvey Region RV site grounds.
- Dogs are allowed but MUST be always kept on a lead whilst outside within the Harvey Region RV Friendly sites. Owners must clean up after their dogs - refer to the *Dog Local Law 2021*.
- No person is permitted to engage in any dangerous behavior while using the Harvey Region RV Friendly sites and facilities if applicable. Refer to the *Local Government Property Local Law 2018*.
- Accessing any power outlet is NOT permitted.
- Use of generators is NOT permitted.
- The quiet time is from 7pm to 7am Monday to Saturday and 7pm to 9am Sundays and Public Holiday.
- Please be kind, courteous and considerate to other visitors, and those around you by observing the Harvey Region RV Friendly quiet times and keeping noise to a minimum. Refer to the *Environmental Protection (Noise) Regulations 1997*.

Management

- The areas are patrolled by Shire Rangers.
- Authorised Officers may inspect vehicles at any time.
- RV use and camping in areas other than the designated sites is prohibited and can be dealt with by modified penalties.

Rights and Responsibility

- The Shire of Harvey is not responsible for any loss or damage.
- We strongly advise you to obtain travel insurance in respect to damage, personal injury, and other related requirements.
- Terms and Conditions are subject to change without notice refer to the *Caravan and Camping Ground Regulation*
